FISH WASTE

- 361. Shri V. P. Nayar: Minister of Food and Agriculture be pleased to state:
- (a) the quantity of fish-waste produced yearly at present by the fishing industry in India; and
- (b) whether Government have investigated the possibility of recovering chemicals useful in the food, cosmetics and pharmaceutical industries from fish-wastes?

The Minister of Food and Agriculture (Shri Kidwai): (a) The production of manure from fish residue after extraction of oil, particularly from sardines, varies from year to year. The production of such manure during 1948-49 was estimated at 936,000 maunds.

fish landing centres are (b) Since numerous and scattered all along the coast of the country and the quantity of fish landed at any one centre is small it has not been practicable to make the investigation in question. Some experimental work in this connection is, however, being done in Bombay and Madras States.

TUBE WELLS ON EITHER SIDE OF BIKANER CANAL

362. Shri Karni Singhji: Will the Minister of Food and Agriculture be pleased to state whether there is any proposal before Government for sinking tube-wells on either side of the Bikaner Canal near Ferozepur Head Works to augment supplies of water when ordinarily the supply of water in the river runs low by the middle of April to end of June?

The Minister of Food and Agriculture (Shri Kidwai): The Government of Rajasthan had such a proposal but the economics of this scheme have vet to be studied.

The Deputy Minister of Railways and Transport (Shri Alagesan): (a) 106 locomotives of the Northern Railway employed on shunting services in station yards are not fitted with headlights. The remaining 1245 locomotives employed in hauling trains are fitted with head-lights. Shunting locomotives are normally not equipped with head-lights.

The Deputy Minister of Railways and Transport (Shri Alagesan): (a) There was a slight fall in the punctuality of passenger trains on this Division during the months of June and July, 1953. The percentage of trains not losing time was 80 in June and 79 in July, 1953.

(b) This was one of the repercussions, on operation, of the acute shortage of water at Janghai and Suraiwan watering stations and heavy incidence of sickness amongst running staff.
