A reduction in the cost price of sulphate of ammonia has also been made and this will tend to reduce the cost of manuring. A compost making drive is also being pursued with a view to cheapening the cost of organic bulk manures.

MINOR IRRIGATION WORKS IN MYSORE

The Deputy Minister of Food and Agriculture (Shri M. V. Krishnappa): (a) and (b). Grants totalling Rs. 102.72 lakhs and loans totalling Rs. 210.20 lakhs were sanctioned to the Government of Mysore for minor irrigation schemes under the G.M.F. during the years 1950-51 to 1952-53.
