(b) whether the Government of India have any scheme to dispose of this land; and

(c) if so, the nature of the scheme?

The Deputy Minister of Defence (Shri Satish Chandra): (a) 98.96 acres of land are surplus to military requirements.

(b) Yes.

(c) The Government of India (Ministry of Defence) have decided to offer for sale all lands surplus to military requirements in the following order of priority:

- (i) Other Ministries of the Government of India.
- (ii) State Governments.
- (iii) Local Bodies.
- (iv) Educational Institutions.
- (v) Ex-soldiers.
- (vi) If none of the above-mentioned is interested, the land will be disposed of by public auction.

SUICIDE IN ORDNANCE FACTORY, KANPUR

412. Shri V. P. Nayar: Will the Minister of Defence be pleased to state:

(a) whether any Court of Inquiry has been ordered or held on the case of suicide in the Ordnance Factory, Kanpur, which occurred on the 13th March, 1954;

(b) if so, what are its findings; and

(c) what action, if any, has been taken in the matter?

The Deputy Minister of Defence (Shri Satish Chandra): (a) No.

(b) Does not arise.

(c) Shri Rangilal, durwan, who committed suicide, being a civilian, the matter had to be reported to the Police who, after making an enquiry, stated that the case was one of suicide. The Superintendent, Ordnance Factory, Kanpur, had made enquiries of his own accord and found that Shri Rangilal had no known trouble but had been having many prescriptions and pamphlets on medicines and that he was in 'indifferent health' generally.
