(b) Specific cases of difficulty in connection with the clearance of personal effects of tourists are invariably looked into, and suitable steps are taken to remove such difficulties as far as possible. Special facilities are granted to the tourists in the matter of quick clearance, restricted examination of baggage, special clearance arrangements, availability of Baggage Declaration form to tourists in transit through Shipping and Aircraft agents. The question of further simplification of Customs formalities is under constant consideration of the Government.

POST-GRADUATE MEDICAL EDUCATION
