that of Major, and the Subedar Major has been retired from Service. A warning has also been given to the Commander and the staff of the Brigade Headquarters.

## EXEMPTION OF TOBACCO FROM EXCISE DUTY

- \*1123. Shri Badshah Gupta: Will the Minister of Finance be pleased to state:
- (a) what steps have been taken to bring to the notice of tobacco-growers information regarding the quantity of tobacco exempted from excise duty: and
- (b) whether any pamphlets have been distributed in regional languages?

The Deputy Minister of Finance (Shri A. C. Guha): (a) and (b). In the course of their visits to tobaccogrowing villages, the Central Excise Inspectors bring to the notice of all tobacco-growers the limits which each grower may retain bacco without payment of duty for his personal consumption. pamphlets have also been circulated in English and regional languages from time to time.

The Deputy Minister of Operation (Shri Satish Chandra): The average annual expenditure on the School is about Rs. 47,000. The school is open not only to officers of the Defence Services but also to civilian officers of the Government of India.
