(b) whether some of these locomotives will be put in use on the Pakala-Dharmavaram Section; and

(c) whether the track in the Pakala-Dharmavaram Section will be strengthened this year in order to make it suitable for these heavier locomotives?

The Deputy Minister of Railways and Transport (Shri Alagesan): (a) No, Sir. The distribution to districts of the locomotives on order has not yet been decided by the Southern Railway.

- (b) No. They cannot run on this section until the track has been strengthened.
- (c) About 90 miles of the track may be strengthened by 1955-56 and the remaining 51 miles probably by 1957-58.

RAILWAY STALL CONTRACTORS FEE

Such a comparison is not feasible as Railways fix licence fees after taking into account the merits of each case based on the sale potential and the conditions locally prevailing. The feasibility of securing greater uniformity in licence fees now charged on the different Railways is, however, under examination at present along with all aspects of catering on Indian Railways.
