The Prime Minister and Minister of External Affairs and Defence :(Shri Jawaharlal Nehru): (a) and +(b). The Indian Trade Agent who is at present touring in Western Tibet, has reported that in his opinion the number of pilgrims coming from India this year is undoubtedly larger than in previous years. not possible to give the exact information asked for until reports from the various check-posts are received at the end of the pilgrimage season in December.

## NORTH EAST FRONTIER AGENCY

706. Shri Rishang Keishing: Will the Prime Minister be pleased to state:

- (a) the number of occasions when military and police have opened fire on the civilians in the North East Frontier Agency since 1952;
- (b) the number of persons (military police and civilians) wounded and killed;
- (c) the number of such cases which have been enquired into and the results so obtained; and
- (d) the amount of money that Government have paid as compensation to the victims and their relatives?
