The Minister of Works, Housing and Supply (Sardar Swaran Singh): (a) 1953-54 Rs. 7:31 Crores.

1954-55 (upto September 1954) Rs. 4.88 Crores.

(b) India, U.K., Canada, U.S.A., Germany, Sweden, Czechoslovakia, Yoguslavia, Holland, France, Switzerland, Austria, Belgium, Denmark, Italy, Hungary, U.S.S.R., Norway Poland and Japan.

नेपाल से अनाज का निर्मात

४६२. श्री विभूति सिश्च: क्या प्रधान संबी यह बताने की कृपा करेंगे कि:

The Prime Minister and Minister of External Affairs and Defence (Shri Jawaharlal Nehru): (a) No Sir. Only a temporary local ban has been imposed in one or two districts which suffered heavily by recent floods. This ban is also likely to be lifted shortly.

- (b) Yes, Sir.
- (c) Under the existing procedure, these farmers can export the produce of their land in Nepal on payment of export duty and without obtaining licences.

ROAD MILEAGE IN ANDHRA STATE

- 463. Shri C. R. Chowdary: Will the Minister of Planning be pleased to
- (a) the mileage (i) that has been completed (ii) that is under construction and (iii) that has to be constructed under the First Five Year Plan under the head State Roads in Andhra during 1951-56 period; and
- (b) the amount allocated for the purpose and the amount utilised sofar?

The Deputy Minister of Planning (Shri S. N. Mishra): (a) and (b). A statement giving the required information is placed on the Table of the House. [See Appendix III, annexure No. 31.] Information regarding the mileage of roads under construction is not readily available in the Planning Commission.
