STEEL INDUSTRY

- 476. Shri S. N. Das: Will the Minister of Commerce and Industry be pleased to state:
- (a) what progress has been made by the Expert Committee appointed to assist Government in the preparation of new schedules of extra charges for the products of the Indian Steel Industry;
- (b) how long it will take the Committee to finish its work;
- (c) whether any time limit has been set for the Committee; and
- (d) whether the steel producing companies have undertaken a detailed work of the study?

The Minister of Commerce and Industry (Shri T. T. Krishnamachari):
(a) The Committee has completed a study of costs of production of different sizes and sections of steel in different countries and is now engaged in working out what should be the appropriate extra charges for sizes and sections produced by Indian Mills in the light of the practice in force in other countries.

- (b) and (c). As the study is of a detailed and technical nature and has been further complicated by the fact that extensive reorganisation and expansion of the existing works is in progress, it is expected that the Committee will take some time yet for finishing its work. No time limit has been set for completion of the work of the Committee, but every endeavour is being made to complete the work as quickly as possible.
