FOREIGN TREATIES

- 9. Shri D. C. Sharma: Will the Minister of Commerce and Industry be pleased to state:
- (a) the nature of the treaties which have been signed with other countries so far for the development of Commerce and Navigation:
- (b) when these treaties have been :signed; and
- (c) how far they have been useful for the development of our Commerce and Navigation?

The Minister of Commerce and Industry (Shri T. T. Krishnamachari):
(a) to (c). Presumably the hon. Member has in mind the various trade agreements which have been entered into with different countries for the purpose of promoting trade. A list of the countries with whom trade agreement have been concluded is attached. "See Appendix I, annexure No. 12.]

Copies of these trade agreements are available in the library of the House.

It is difficult to assess precisely the effect of a trade agreement on the trade between any two countries as there may be various other factors also which may have influenced trade. On the whole, however, trade agreements do appear to have helped in promoting trade and navigation.

N.E.S. BLOCKS IN PUNJAB
