the safety of the mail line was not assured; (ii) suitable persons were not available to work as Extra Departmental Agents; and (iii) the cost exceeded the permissible limit of loss of Rs. 750 per annum?

The Deputy Minister of Communications (Shri Raj Bahadur): (a) 133. There are written protests only from the Managers of the 39 Tea Estates in West Bengal. There are no written protests in regard to the rest.

The Deputy Minister of Railways and Transport (Shri Alagesan): (a) to (c). Surveys for over 4,000 miles of new Railway lines have been carried out during the post-war period. A list of new Railway lines opened to traffic after World War II and also those under construction at present is attached. [See Appendix I, annexure No. 182.] Due to restricted resources, the programme for the construction of new lines had to be confined only to those falling under the following categories:---

(a) which were either of vital national importance or

(b) which were otherwise found inescapable taking into consideration the needs of particular areas, or

(c) which were considered essential for the agricultural, industrial and mineral deevlopment of the country in connection with the implementation of the First Five Year Plan.

EMPLOYMENT EXCHANGES

44. Sardar Hukam Singh: Will the Minister of Labour be pleased to state:

(a) the number of persons registered with Employment Exchanges and those still seeking assistance through these Exchanges as on the 31st August, 1954 and 31st October, 1954, respectively; and (b) whether there is a decline in the fresh registrations or renewals of registration?

The Minister of Labour (Shri K. K. Desai): (a) Figures for October, 1954 are not yet available. The number of registrants on the last date of the three months preceding October, 1954 were:—

(b) During July the combined number of fresh registrations and reregistrations increased by over 15,000 but in August it declined by over 30,000 and in September, by a further 5,000.

(a) whether a decision has since been taken to treat 50 per cent. of the dearness allowance of the employees of *ex*-Nizam's State Railway who have opted to retain pre-absorption terms and conditions of service, as dearness pay; and

(b) if not, the reasons for the delay?

The Deputy Minister of Rallways and Transport (Shri Alagesan): (a) No.

(b) A decision in this matter has to be taken in consultation with the other Ministries concerned since Government as a whole is concerned. This consultation is in progress.
