REFUGEES IN KASHMIR

Joshi: 321. Shri Krishnacharva Will the Minister of Rehabilitation be pleased to state:

- (a) the total number of persons who have migrated since 1949 from Pakistan occupied territory of Kashmir to Jammu and Kashmir State; and
- (b) the measures adopted to habilitate them?

The Deputy Minister of Rehabilitation (Shui J. K. Bhousie): (a) No regular statistics regarding the migration of persons from the Pakistan occupied territory of Kashmir Jammu and Kashmir State have been maintained by the State Government. According to the information made available by the State Government, approximately 1,21,000 persons are estimated to have arrived since 1947.

- (b) (i) Rehabilitation loans have been given at Rs. 500/per family for agricultural and housing purposes.
 - (ii) Lands varying from 4 to 6 acres per family have given according to the size of the family and nature of land.
 - (iii) A scheme has been drawn up for the construction nŧ Colonies in Jammu and Kashmir State for housing the displaced persons.

INDESTRIAL HOUSING SCHEME

- 822. Shri D, C. Sharma: Will the Minister of Works, Housing Supply be pleased to state:
- (a) the amount so far given to the Punjab State under the subsidized Industrial Housing Scheme; and
 - (b) how it has been utilised?

The Minister of Works, and Supply (Sardar Swaran Singh): (a) Rs. 2.02 lakhs as subsidy and Rs. 3:26 lakhs as loan have been paid to the Punjab Government so far out of the sanctioned subsidy, of Rs. 4'82 lakhs and an equal amount of loan for the construction of 382 tenements for industrial workers.

(b) The amount has been utilised on the construction of 200 tenements at Amritsar and 124 tenements Ludhiana, Fifty-eight tenements are yet to be built at Batala.
