- (g) if so, the mode of their selection?

The Minister of Works. Housing and Supply (Sardar Swaran Singh): (a) The printing presses under the control of the Ministry are located as follows: Delhi—3: Calcutta.—2; Simla. - I; Nasik. - I; Aligarh. - I; Nilokheri.-I.

- (b) Yes, Sir.
- (c) In the main Press at Calcutts and New Delhi.
- (d) The figures vary from year to year. Before the War, one apprentice used to be recruited every year, but during the war, recruitment was suspended. Since then one apprentice was recruited in 1948, two in 1949, two in 1951 and four in 1952.
- (e) The candidates have to graduates in the age group of 17-22 years and the period of training is 4 years, which can be reduced to 3 in the case of industrial employees already working in the presses.
 - (f) Yes, Sir.
- (g) The selection is made by the Controller of Printing and Stationery after inviting applications through advertisement.
