बाणिज्य तथा उद्योग मंत्री (श्री टी० टी० कृष्णामाचारी): (क) और (ख). जी हां, ज्ञात हुआ है कि इस प्रकार का एक प्रस्ताव योजना कमीशन को मिला है।

(ग) जी नहीं, एफ० ए० आ० के कागज और लुग्दी विशेषज्ञ द्वारा कच्चे माल का सामान्य पर्यवेक्षण किये जाने के अतिरिक्त केंद्रीय सरकार ने हिमाचल प्रदेश के विषय में अब तक और कोई खास पर्यवेक्षण नहीं कराया है।

ENQUIRY COMMITTEE ON COKE-OVEN PROJECTS

*1996. Shri S. N. Das: Will the Minister of Planning be pleased to state:

(a) whether the expert Enquiry Committee on Coke-Oven Projects appointed by the Planning Commission has finished its work and submitted its report; and

(b) if so, whether the report has been considered and decision taken with regard to the establishment of Coke-Oven and by-product plants by the West Bengal Government?

The Deputy Minister of Irrigation and Power (Shri Hathi): (a) An interim report dealing with the Coke-oven plant and allied schemes, envisaging the recovery of by-products from coke-oven gas and products from the distillation of coal-tar, was submitted to the Planning Commission by the Coke-oven Projects Enquiry Committee on 31st March, 1955.

(b) The interim report is expected to be considered by the Planning Commission in consultation with the Central Ministries at an early date.

IMPORT OF RAILS

*1999. Shri Raghunath Singh: Will the Minister of Commerce and Industry be pleased to state whether it is a fact that India is importing 40,000 tons of rails from Japan for the use of Indian Railways?

The Minister of Commerce and Industry (Shri T. T. Krishnamachari): Yes, Sir, 50,000 tons.

WORK IN THE CENTRAL SECRETARIAT

603. Sharimati Ganga Devi: Will the Prime Minister be pleased to state:

(a) the number of receipts both ordinary and important an Assistant in the Central Secretariat is expected to deal in a week;

(b) whether it is a fact that the Assistants in the Central Secretariat Service are over-worked; and

(c) if so, whether Government are taking any steps in the matter?

The Parliamentary Secretary to the Minister of External Affairs (Shri Sadath Ali Khan): (a) The time, labour and attention needed for dealing with receipts depends upon their nature and complexity. This varies

from Ministry to Ministry and even from Section to Section. The old attempt to lay down a uniform standard has been abandoned.

(b) No.

(c) Every Section Officer is expected to maintain a close watch over the distribution of work among the Assistants under his charge. O.&M. Division have also instituted certain control measures to watch the flow of work, e.g., Assistant's Daily Diary and the Weekly and Monthly Arrears Statements which furnish enough data to see whether there is over-loading or under-loading in particular instances.

SHIPPING FREIGHT RATES

604. **Shri Tulsidas:** Will the Minister of Commerce and Industry be pleased to state:

(a) whether the Indian Delegate at the ECAFE Trade Promotion Conference at Hongkong had raised the question of discriminating shipping freight rates;

(b) whether the ECAFE had agreed to conduct a survey in this respect;

(c) whether the Government of India have conducted a preliminary survey of the discriminating freight rates charged by the foreign shipping concerns; and

(d) if so, the results of this preliminary survey?

The Minister of Commerce and Industry (Shri T. T. Krishnamachari):

(d) The preliminary examination which was conducted in respect of certain selected goods, showed that the freight rates charged from India to destinations near at hand were higher than those charged from certain countries in Europe to the same destinations, although they involved shipment over much longer distances. A special officer has been appointed to

examine how far this difference in freight rates is justified on economic considerations, and his report is awaited.
