ECONOMIC SURVEY OF HIRAKUD PROJECT

710. Shri Sanganna: Will the Minister of Irrigation and Power be pleased to refer to the reply given to starred question No. 40 on the 15th November, 1954 regarding the economic survey of the Hirakud Dam Project by the Gokhale Institute of Politics and Economics and state the progress so far made in the matter?

The Deputy Minister of Irrigation and Power (Shri Hathi): The Government of Orissa, who are responsible for having the survey conducted. have reported as follows:-

The urban surveys in the towns of Puri and Sambalpur relating to income, employment, trade and industry have been completed. Similarly the rural surveys conducted on a random sample basis about general family conditions i.e. their occupation, income, employment etc. and the enquiry into the conditions of agriculture in the selected grids have also been completed. All this constitutes about two-thirds of the field work connected with the economic survev.

The rest of the field work relating to enquiries into the conditions landless labour, artisans, professionals etc. is now in progress.
