राजा तामाव स्टंशन

७४६. श्री रूप नाराचण : क्या रंताचे मंत्री यह बताने की कृपा करेंगे कि :

- (क) पूर्वोत्तर रलवे के राजा तालाब नामक स्टेशन पर विजली की व्यवस्था करने में प्रीत मास कितना औसत व्यय होता है :
- (ख) इस स्टंशन से प्रति मास कितनी औसत आय होती हैं
- (ग) प्रति मास ऑसतन कितनी राशि के टिकट विकते हैं
- (घ) प्रति रात्रि असितन कितने यात्री इस स्टेशन का उपयोग करते हैं. और
- (ह.) इस लोट से गामीण स्टंशन पर विजली की व्यवस्था करने में अत्यधिक व्यय करने की क्या आवश्यकता थी?

रंलवे तथा परिवहन उपमंत्री (श्री अलगेशन):

- (क) ६४४ रुपरो ।
- (ख) २.०४० रुपये।
- (ग) ९.६७६ रुपये।
- (घ) लगभग ३८ प्रति दिन ।
- (इ.) राजा तालाब स्टंशन पर इंजनों को पानी दिया जाता है। यहां पम्प से पानी खींचने के लिये पहले आमतार पर आठ आदमी (Pump-men) रखे जाते थे। ९६४४ में पिछले क्रम्भ मेले के समय जब बड़ी संख्या में गाहियां चलने वाली थीं, इंजनों के

लिये बहुत अधिक पानी की जरूरत महसूस हर्ड। यह समभा गया कि हथ-पम्पों से अधिक पानी निकालने के लिये अधिक आदमियों को काम पर लगाने के बजाय इस स्टंशन पर पानी की जरूरतों को पूरा करने के लिये विजली का पम्प लगाना अधिक स्विधाजनक होगा और इस पर खर्च भी कम होगा। चंकि विजली मिल रही थी. इस स्टेशन पर विजली की बीतयां और पंत्रों भी लगा दिये गये. ताकि कम्भ मेले के अवसर पर इस स्टेशन से भारी संख्या में गुजरने वाले यात्रियों को आराम दिया जा सके।

यात्रियों को आराम देने के विचार से मेले के बाद भी इस स्टंशन पर बिजली का प्रबन्ध रहने दिया गया है।

TUBE-WELL SCHEMES IN MADRAS

- 760. Shri Balakrishnan: Will the Minister of Food and Agriculture be pleased to state:
- (a) whether it is a fact that Central Government have requested the Madras Government to abandon the tube-well scheme in that and
 - (b) if so, the reasons therefor?

The Deputy Minister of Food and Agriculture (Shri M. V. Krishnappa): (a) No.

(b) Does not arise.

TELEPHONE EXCHANGE AT PALNI

- 761. Shri Balakrishnan: Will the Minister of Communications be pleased to state:
- (a) whether it is a fact that a Telephone Exchange was not installed in the Palni Telegraph Office due to paucity of accommodation there; and
- (b) whether it is now proposed to shift the Telegraph Office to a suitable building in the near future so as to provide a Telephone Exchange there?

The Deputy Minister of Communications (Shri Raj Bahadur): (a) and (b). There has been no proposal instal the new exchange in Palni telegraph office. The exchange will accommodated in some other rented building. There is also no proposal at present to shift the telegraph office.

POSTAL INSPECTORS

- 762. Shrimati Renu Chakravartty: Will the Minister of Communications be pleased to state:
- (a) the period of service in the cadres of Inspectors of Post Offices and R.M.S. needed to qualify for the appointment in the cadre of Superintendents of Post Offices and R.M.S., Class II:
- (b) whether any departures been made in this regard; and
 - (c) if so, the reasons therefor?

The Deputy Minister of Communications (Shri Raj Bahadur): Five Years' continuous service in the grade of Inspectors of Post Offices or R.M.S. followed by confirmation in that grade.

(b) Yes.

(c) An officiating Inspector R.M.S. who had over five years' continuous service in that grade but had not yet been confirmed was recommended by the Head of a Circle for selection, along with others to Postal Superintendents' Service, Class II in 1954 and he was selected along with others on the advice of a regularly constituted Departmental Promotion Committee, and specially placed on the approved list, as he was the only Scheduled Caste/Scheduled Tribe eligible official.

GAZETTED OFFICERS OF P. & T. DEPART-

763. Shrimati Renu Chakravartty: Will the Minister of Communications be pleased to state:

(a) the maximum period for which Gazetted Officers in the Posts and Telegraphs Department are posted for service at one station; and

(b) the circumstances under which extensions for stay at a particular station are allowed to them?

The Deputy Minister of Communications (Shri Raj Bahadur): (a) Ordinarily, for a period of four years when there are more than one post at different stations in the cadres to which they belong.

(b) Extensions are given in the interest of administration, or when it is considered that transfer of an officer at a certain time will cause hardship to him, especially in regard to education of his children.

EMPLOYEES OF FORMER AIR INDIA LTD.

764 Shri Tushar Chatterjea: Will the Minister of Communications pleased to state:

- (a) whether Government are aware that the Indian Air Lines Corporation has by a Resolution decided to grant an ad-hoc increment with effect from the 1st August, 1953 to the employees of the former Air India Ltd., whose increments fell due between October, 1952 and July, 1953; and
- (b) if so, whether the said decision has been implemented?

The Deputy Minister of Communications (Shri Raj Bahadur): (a) The Indian Airlines Corporation at Seventh Meeting held on 14th April, 1954, decided that each ex-employee of Messrs. Air India Ltd., who would have, but for the general ban accrual of increments, earned an increment on a date between the 1st October, 1952 and the 31st July, 1953, be allowed an ad-hoc increment with effect from the 1st August, 1953, with future increments thereafter accruing on the 1st of August each year.

(b) The above decision was implemented on the 17th January, 1955.

TRADE UNIONS OF EMPLOYEES OF AIR CORPORATIONS

- 765. Shri Tushar Chatterjea: Will the Minister of Communications be pleased to state:
- (a) whether there are any recognised Trade Unions of the employees of the Indian Airlines and Air India International Corporations; and
