(ii) illustrative examples indicating the increases in disability and special family pension and children's allowance, in respect of personnel below officer rank.

Owing to the complexities of the rules, it is not possible to indicate the exact amount of increase for every individual category.

The proposed increases will involve an expenditure of Rs. 1,10,000 per annum approximately in respect of retirements, disablements or deaths. during the period from 1st September. 1949 to 31st December, 1954.

- (c) The enhanced rates of pension will be granted with effect from the 1st June, 1953, or from the date from which a pension is admissible, whichever is later, and will be confined to cases where the pensioner is alive on the date of issue of the Government orders embodying the decision.
