- (b) how many of these surplus grounds were utilised for Government purposes and how many were auctioned; and
- (c) the amount of sale proceeds of such auctions?

The Deputy Minister of Defence (Sardar Majithia): (a) 38.

- (b) None of these were utilised for Government purposes nor sold by auction but most of them were leased out for agricultural purposes pending final disposal.
 - (c) Does not arise.

TRIPURA GOVERNMENT EMPLOYEES

- *1420. Shri Dasaratha Deb: Will the Minister of Home Affairs be pleased to state:
- (a) whether there are any Government quarters for Class III and Class IV employees of the Tripura Government in the Divisional Towns;
- (b) whether the Employees' Association in their annual general meeting of 1954 demanded such quarters; and
- (c) whether Government have any plans in this connection?

The Deputy Minister of Home Affairs (Shri Datar): (a) to (c). The information has been called for from the Tripura Administration, and will be laid on the Table of the House as soon as it is received.

LIGNITE MINES IN RAJASTHAN

- 416. Shri Karni Singhji: Will the Minister of Natural Resources and Scientific Research be pleased to state:
- (a) whether any proposal for the development of the Lignite Mine at Palana (Rajasthan) has been received from the Government of Rajasthan; and

(b) if so, the decision taken in the matter?

The Minister of Natural Resources (Shri K. D. Malaviya): (a) Yes. Sir.

(b) The proposal is at present under consideration.

COMPENSATORY ALLOWANCES

- 417. Shri Biren Dutt: Will the Minister of Home Affairs be pleased to state:
- (a) whether the compensatory allowances granted to the Tripura State employees are proposed to be withdrawn; and
 - (b) if so, the reasons therefor?

Minister of Home Deputy Affairs (Shri Datar); (a) and (b). The compensatory allowance was sanctioned purely as a temporary measure of relief with effect from the 1st January, 1954, and until the opening up of traffic on the Assam-Agartala Road. road was ceremonially opened on the 4th Febraury, 1955, but is not yet open for normal traffic. The question whether there has been material change in the circumstances in which the allowance was sanctioned is being examined.

INDUSTRIAL FINANCE CORPORATION

- 418. Shri D. C. Sharma: Will the Minister of Finance be pleased to state:
- (a) the number of applications received from the Punjab State demanding loans from the Industrial Finance Corporation of India during 1954; and
- (b) the names of the concerns which were granted loans and the amount of loans paid to each?

The Minister of Revenue and Defence Expenditure (Shri A. C. Guha): (a) and (b). Only four appli-

cations were received from the Punjab State during 1954. Out of these two concerns, namely (1) Atlas Cycle Industries, Ltd., and (2) Saraswati Sugar Syndicate, Ltd., have been sanctioned loans of Rs. 5 lakhs and Rs. 35 lakhs, respectively.

PETROLEUM IN WEST BENGAL

- 419. Shri S. C. Samanta; Will the Minister of Natural Resources and Scientific Research be pleased to state:
- (a) the names of the districts in West Bengal where aeromagnetic survey for petroleum has been completed by the Standard Vacuum Oil Company; and
- (b) the names of those olaces where prospecting of petroleum has been undertaken?

The Minister of Natural Resources (Shri K. D. Malaviya): (a) The Standard Vacuum Oil Company carried out an aeromagnetic survey over the West Bengal alluvial-covered tract of 25,000 sq. miles comprising all the districts.

(b) No prospecting for petroleum has yet been undertaken by the Company but only a seismic refraction survey is now being carried on by the Standard Vacuum Oil Co. over an approximate area of 10,000 sq. miles.
