- (d) and (e). Representations have been received and examined. The basis for the assessment of rent in Gandhi Nagar Colony is the same as in any other colony in the State of Bombay. As the rents have been levied according to a prescribed formula, which is considered reasonable, it has not been thought necessary to revise the rents.

## Residential Accommodation

The Minister of Works, Housing and Supply (Sardar Swaran Singh): (a) There is no avoidable delay in completing construction of buildings taken in hand. The quarters which are completed are also allotted without delay. To the extent that there is still shortage of accommodation, the House Rent allowance continues to be paid.

(b) Every effect is being made to complete the buildings inclusive of all services as expeditiously as practicable.
