(b) if so, the reason for jthis slow speed;

(c) whether there is any proposal to augment its speel; and

(d) if so, from when ?

The Deputy Minister of Railways and Transport (Shri Alagesan) : (a) No. The time-table journey-time of the passenger trains running on the Section is 8 hours 5 minutes and that of the mixed trains varies from 8 hours 15 minutes to 9 hours 20 minutes.

(b) The speed of trains is dependent on the standard and stength of track and bridges.

(c) and (d). It will take some length of time before the works in connection with the stengthening of track and bridges which have been programmed, are completed to permit of improvement in the journey-time of trains.

Tezpur-Rangiya Rail Line

504. Shri K. P. Tripathi : Will the Minister of **Railways** be pleased to refer to the reply given to unstarred question No. 393 on the 22nd March, 1955 and state :

(a) whether orders have been issued for the ballasting of the railway linebetween Tezpur and Rangiya; and

(b) if so, when the ballasting is likely to be taken up ?

The Deputy Minister of Railways and Transport (Shri Alagesan) : (a)and(b) The section between Rangiya and Ringipira is alreidy ballasted a length of 24 miles with stone and 53 with shingle. The ballasting of the section between Rangapara and Tezpur with shingle is proposed to be taken up during the next financial year.

Improvement on Stations

505. Shri Kamath : Will the Minister of Railways be pleased to state:

(a) which of the following Stations on the Central Raiiway—Betul, Hoshangabad Itarsi, Sohaqpur Pipariya. Gadarwara, Kaveli, Narsinghpur and Gotegaon have been included in the First Five Year Plan for improvement and expansion;

(b) which of these will be 'taken up for improvement and expansion in the course of the Second Five Year Plan; and

(c) the main features of the improvement and expansion pla in each cas? The Deputy Minister of Railways and Transport (Shri Alagesan): (a) Passenger Amenity Works have been or are being provided at all these stations in the First Five Year Plan period.

(b) The Second Five Year Plan is still to be finalised.

(a) whether it is a fact that some representations have been made to Government postponing the realisation of agricultural loan from the peasants of Kamalpur in Tripura this year; and

The Minister of Food and Agriculture (Shri A. P. Jain) : (a) No such representation has been received.

508. Mulla Abdullabhai : Will the Minister of Health be pleased to state :

(a) the number of persons who have been B.C.G. vaccinated so far in Madhya Pradesh;

(b) whether any of them has suffered from any unfavourable rection ; and

(c) whether any of them had contracted Tuberculosis ?
