Water Charges

1168. Chaudhri Muhammed Shaffee : Will the Minister of Communications be pleased to state :

(a) whether it is a fact that class IV employees of the Posts and Telegraphs Department in Delhi are paying rupee one and annas eight as water charges for the water community taps whereas the class IV employees of the other Departments are paying twelve annas only ;

(b) if so, the reasons for this disparity; and

(c) when these charges will be reduced ?

The Deputy Minister of Communications (Shri Raj Bahadur) (a) and (b). There is the disparity as pointed out. In the P. & T. Department in Delhi and New Delhi, the charges of Rs. 1-8-0 have been fixed in reference to the actual consumption of water in the quarters and even then this rate is a concessional one inasmuch as the balance of water charges which works out to about Rs. 6,600 per ennum is paid by the P. & T. Department.

(c) The case will be reviewed after 31-3-1956 in order to see if any revision is possible.

Passenger Amenities

1173. Shri Dabhi : Will the Minister of **Railways** be pleased to state the progress made so far on Passenger Amenities works on the Western Railway during the year 1955-56?

The Parliamentary Secretary to the Minister of Railways and Transport (Shri Shahnawaz Khan): Out of a total of 408 works, 31 works have already been completed, 245 are in progress and 132 are still required to be taken in hand, for which either the estimates have been sanctioned or are in the process of sanction.

Against an allotment of Rs. 60 lakhs, Rs. 2,78,000 had been spent upto end of May, 1955. The progress of expenditure in the first two months of the financial year is generally slow on account of the start of the financial year and increases as the financial year advancess and the tempo of work is accelerated. The Railway expects to spend the entire allotment made to them during the year.
