(b) whether any minimum educational qualification is necessary for the promotion of class IV staff of lower grade to higher grade where a re ular avenue of promotion exists?

The Deputy Minister of Rail ays and Transport (Shri Alagesan): (a) Posts in the grade Rs. 55—85 are i.led by promotion of class IV staff.

(b) No, Sir, but a minimum standard of literacy is essential.

संचार उपमंत्री (श्री राज बहाबुर) : सन् १६५५-५६ का "बुकिंग एजेंसी कमीशन" शीर्ष के व्यय का अनुमान पिछले वर्ष के व्यय के अनुमान से दो लाख पचपन हजार रुपये कम है । कमी का कारण यह है कि "बुकिंग एजेन्टों" की संख्या में कमी हुई है और कारपोरेशन बुकिंग का स्वयं कुछ अधिक काम करना चाहती है ।
