These Corps were paid for and maintained by the old Political Department and were never treated as a part of the Armed Forces. Even the Mewar State Government to whom the Mewar Bhil Corps was transferred on 1st April, 1938, did not treat it as a regular Indian State Force unit. These Corps therefore continued to be treated as irregular units.

Civilians in Ordnance Depots

919. Shri M. S. Gurupadaswamy: Will the Minister of Defence be pleased to state:

- (a) whether it is a fact that the Army Standing Establishment Committee have recommended a large reduction in the strength of various categories of civilians employed in Ordnance Depots;
- (b) whether there has been any corresponding reduction in workloads; and
- (c) the decision taken by Government?

The Deputy Minister of Defence (Sardar Majithia): (a) The Committee have recommended a reduction in the strength of some categories of civilians. The net decrease in total strength recommended is about 6.5%.

- (b) Yes.
- (c) The case is under examination of Government.

Central Food Technological Research Institute, Mysore

920. Shri Wodeyar: Will the Minister of Natural Resources and Scientific Research be pleased to state:

The Minister of Natural Resources (Shri K. D. Malaviya): (a) Annual recurring expenditure, at present, is approximately Rs. 10 lakhs.

(b) In Field units, Khalasis have to perform the duties of night guards in turn as reliable guards specially recruited are not easily available. Those who perform these duties are given time off in lieu.

Survey of India

- (a) whether it is a fact that the contingent Khalasis employed in the field parties of Survey of India are not paid rail fares when recruited for reporting to the place of duty;
- (b) whether they are also not paid rail fares to reach their homes after completion of the field season; and

The Minister of Nartural Resources (Shri K. D. Malaviya): (a) and (b) Yes, Sir.

(c) The Government do not as a rule pay Travelling Allowance to employees borne on contingent establishment at the time of recruitment and discharge.

Confirmations in I.A.S. Cadre

- (a) the rules that govern the confirmation of State officers promoted to the I.A.S. cadre against 25 per cent quota in the senior scale of the I.A.S. cadre;

 - (c) the reasons therefor?

The Deputy Minister of Home Affairs (Shri Datar): (a) Under the I.A.S. (Recruiment) Rules ther is no officiating promotion to the I.A.S. All officers promoted to the 25 per cent quota are automatically regarded as confirmed in the senior scale of the I.A.S.

(b) and (c) Do not arise.

Uplift of Scheduled Castes and Scheduled Tribes

928. Shri Sanganna: Will the Minister of Home Affairs be pleased to state:

- (a) whether the State Governments have integrated in their Second Five Year Plans any special schemes for the socio-economic and cultural pro ress of the Scheduled Castes and the Scheduled Tribes; and
- (b) if so, what are they and the names of the States where they are to be executed?

The Deputy Minister of Home Affairs (Shri Datar): (a) Yes.

(b) They are many and are contained in practically all the State Plans which are at present under finalisation by the States in consultation with the Planning Commission. The details could be had as soon the Plans are final.
