The Deputy Minister of Production (Shri Satish Chandra): (a) to (c). Government has not given any grants to firms. Besides several institutions, a grant of Rs. 10,000/- was paid to Shri N. R. Das of Pan Bazar, Gauhati, who had designed tassar and m"ga reeling and Eri Silk Spinning machines, to enable him to carry on further experiments on spinning and reeiing machines. Also, a grant of Rs. 1,000/- was paid to Shri Joe Curean of Travancore-Cochin State, who has invented a pocket charkha, to enable him to carry on further experiments on his invention.
