### Displaced Persons Colonies in Delhl

- (a) whether it is a fact that the Government of India have approved the scheme of the Delhi State Government for providing basic civic amenities to the people living in displaced persons' colonies in Delhi; and

The Minister of Rehabilitation (Shri Mehr Chand Khanna): (a) and (b). No such scheme has been received from the State Government. But a provision of Rs. 48.6 lakhs has been made during the year 1955-56 for providing civic amenities and undertaking development works.

The raising of resources to fill any gap that may remain after Central assistance or in special cases ways and means assistance has been made available to State Governments is the responsibility of the State Governments themselves,
