RESETTLEMENT OF EX-SERVICEMEN

804. Shri Ram Krishan: Will the Minister of **Defence** be pleased to state the progress made so far in regard to the development of colonies of Mahabalipur—Randhirpura, Bannur and Ghabdan in Pepsu for re-set-tlement of *ex*-servicemen?

The Deputy Minister of Defence (Sardar Majithia): Rupees three lakhs have so far been advanced as loan by the Centre to the State Government to enable the latter to proceed with the development of the land Colonies for Ex-servicemen in PEPSU; and the progress made so far is as under :---

Mahabalipur-Randhirpura (Kapurthala District)

The layout of the village and plots has been marked. 250 acres of land have been reclaimed by tractors. A tubewell has been installed. A Panchayat Ghar is under construction. The design of settlers' quarters has been finalized and the construction will commence shortly.

Bannur (Patiala District)

The land has been acquired and consolidation of holdings is in progress. The layout plan of the village has been prepared. A tubewell is being sunk.

Ghabdan (Sangrur District)

Land acquisition proceedings have been completed. Reclamation operations, however, could not be started as some of landowners subsequently represented against the acquisition of their land. The matter is under consideration by the Government of PEPSU.

300 ex-servicemen will be settled in these colonies.
