#### CHUREB FLAG STATION

**893. Shri Dhusiya:** Will the Minister of Railways be pleased to state whether Government are contemplating to convert the Chureb Flag Station into a 'B' class Station on the N. E. Railways?

**The Deputy Minister of Railways and Transport (Shri Alagesan):** Yes There is a proposal to convert Chureb Flag Station into a crossing station during the Second Five Year Plan.

#### REFRESHMENT ROOM AT SAHARSA JUNCTION

**894. Shri L. N. Mishra:** Will the Minister of Railways be pleased to state:

(a) whether it is a fact that Refreshment Room was sanctioned for Saharsa Junction (North-Eastern Railway) in Bihar; and

(b) if so, the main reasons why it has not yet started functioning?
