He did not also hold any consultations on grading either with traders or with Government Officials.

- (b) the steps that have been taken to minimise the frequencies of such interruptions; and

The Minister in the Ministry of Communications (Shri Raj Bahadur):
(a) In the year 1955, the Patna-Delhi trunk circuit was out of order on 266 occasions. The average duration of an interruption was 2:00 hrs. not taking into account the general breakdown of lines totalling 100 hours.

- (b) Most of the interruptions were caused by copper wire thefts in Sections Patna-Banaras and Banaras-Lucknow and consequent disturbances to lines due to repair work. Close liaison is maintained with the Police and certain other measures are being adopted to discourage the thefts.
- (c) The additional measures referred are in the process of introduction and the results are awaited.
