- (b) when were the orders for the constitution of the said Cadre issued;
- (c) when was the said Cadre brought into being;
- (d) whether it is a fact that permanent and temporary Assistants have not been specifically appointed to any

particular posts in any particular office or Ministry but have been allowed to work in an office or Ministry to the extent that there are requisite number of posts in that office or Ministry irrespective of whether those posts are temporary or permanent and whether the persons holding those posts are temporary or permanent Assistants; and

(e) if so, whether it is permissible to allow a temporary Assistant to work in a permanent post and a permanent Assistant in a temporary post?

## The Minister in the Ministry of Home Affairs (Shri Datar): (a) Yes.

- (b) The Instructions for the constitution of the Regular Temporary Establishment were finalised and issued in August 1952.
  - (c) From 1st July 1952.
  - (d) Yes.
- (e) Yes. In fixing the permanent strength of Grade IV of the Central Secretariat Service we have taken into account a certain proportion of posts which, though sanctioned on a temporary basis, are expected to last indefinitely. The permanent and Temporary posts have relation to the number of such posts sanctioned on the Establishment of each Ministry/Office, while confirmations in Grade IV of the Central Secretariat Service are made on a Centralised basis, with reference to the permanent strength of that Grade.
