(c) whether the number of animals imported and exported during the year has increased as compared to the previous year; and

(d) if so, by how much?

## RICKSHAW PULLING

# 976. { Shri Ram Krishan: Shri Deogam:

Will the Minister of Labour be pleased to state the steps Government have taken so far to implement the recommendations of the Labour Ministers' Conference regarding the abolition of Rickshaw pulling?

The Deputy Minister of Labour (Shri Abid Ali): The State Governments have been requested to implement the recommendations of the Labour Ministers' Conference regarding gradual abolition of rickshaw plying. The model regulations to govern the conditions of work of rickshaw pullers, contemplated in the recommendations, are under preparation, and will be circulated to State Governments at a very early date.

#### AERODROMES

977. Shri Ram Krishan: Will the Minister of Communications be pleased to state:

(a) whether the scheme to equip the existing and new aerodromes with the operational and night-flying equipment during Second Five Year Plan has been finalised; and

(b) if so, the main features thereof?

The Minister in the Ministry of Communications (Shri Raj Bahadur): (a) A scheme has been finalised subject to the approval of the Planning Commission.

(b) if so, when the work will be taken up?

The Deputy Minister of Railways and Transport (Shri Alagesan): (a) It is proposed to undertake a traffic survey only for the present.

(b) In view of the funds for the construction of new lines having been drastically curtailed, the chances of construction of this line during the Second Five Year Plan Period are rather remote.
