SCRAP TELEGRAPH WIRES

1041. Shri K. R. Sharma: Will the Minister of Communications be pleased to state:

(a) whether used up and unserviceable telegraph wire is got flattered with a view to its disposal as scrap copper; and

(b) whether a suggestion has been made to Government that instead of flattering the wire its gauge may be changed which will fetch a better price in the market?

The Minister in the Ministry of Communications (Shri Raj Bahadur): (a) Yes. This is done in order to meet the provisions of the Telegraph Wires (Unlawful Possession) Act, 1950.

(b) Yes. But the parties could not either draw wire according to departmental specifications, or meet the essential conditions of the contract.
