The Minister of Revenue and Defence Expenditure (Shri A. C. Guha): The Managing Director of the Imperial Bank of India was in receipt of a salary of Rs. 7,500 per month and entertainment allowance of Rs. p.m. He was also receiving months salary as bonus each year and the benefit of a free residence at Bombay and Calcutta and free conveyance. He was appointed as the first Managing Director of the State Bank of India and his remuneration was fixed by the Central Government at Rs. 4,500 per month plus house rent for his residence at Bombay, together with a personal allowance amounting to Rs. 2,000 per month in the first year from the 1st July, 1955 and Rs. 1,000 per month in the next year and 'nil' thereafter. The entertainment allowance of Rs. 500 per month which was discontinued on the establishment of the State Bank, was subsequently restored to the Managing Director. No bonus is admissible to the Managing Director since the inception of the This was done on the State Bank. recommendation of the Board of Directors of the State Bank as some subordinate officers were getting higher salaries.

A Second Managing Director was recently appointed by the Central Board of the State Bank and his remuneration was determined by the Board with the approval of the Central Government as required under Section 29(2) of the Act as indicated below:

Pay Rs. 3000 p. m.

Compensatory allowance Rs. 100 p. m.

House rent allowance Not exceeding 12½% of pay in excess of the first 10% which will be borne by the officer.
