SETTLEMENT IN ANDAMAN ISLAND

- 2133. Shri B. S. Murthy: Will the Minister of Home Affairs be pleased to state:
- (a) whether it is a fact that certain families from Andhra were prepared to go to Andamans for settling down there but have not yet been given facilities for travelling in this connection; and

Accordingly, a provision for 600 families (at the rate of 5 acres per family) was made and Andhra was given a quota of 60 families. Later, however, it appeared that the area of cleared land which would be available would be much less than originally estimated, and therefore some of the States including Andhra, were asked to wait until further land could be made available.
