1084. Shri Rishang Keishing: Will the Minister of Home Affairs be pleased to state:

- (a) whether it is a fact that about 28 persons from different departments of the Manipur Government are under suspension and their cases are now pending in the Courts as well as in police;
 - (b) if so, the nature of their cases;
- (c) the dates of their suspension; and
- (d) the steps taken to dispose of their cases finally?

The Minister in the Ministry of Communications (Shri Raj Bahadur): (a) 21 Government Servants are under suspension; only 19 cases pending with the Court or the Police.

- 2 cases are under departmental enquiry.

BRIDLE PATH IN MANIPUR
