A contract has, however, been concluded between the Government of India on the one part and the Ministry of Iron and Steel U.S.S.R. and "Technoexport" on the other for the

supply of 60,000 metric tons of structural steelwork for the Bhilai Iron and Steel Works. The first consignment is expected to arrive in India this year and the entire supply completed by the middle of June, 1959.
