1348. Shri D. C. Sharma : Will the Prime Minister be pleased to state :

(a) whether he is aware of the fact that the Rev. Benjamin Munez, permanent representative of Costa Rican in the U. N. said in Bombay on July 9, 1956 that the Latin American nations will be pleased to use their good offices in bringing about a settlement between the Governments of India and Portugal on the Goa issue; and

(b) if so, whether the Government of India will make use of this offer?

The Prime Minister and Minister of External Affairs (Shri Jawaharlal Nehru) : (a) Yes.

(b) The statement made in Bombay on the 9th July, 1956, by Rev. Benjamin Munez, Permanent Representative of Costa Rica to the United Nations was not in the nature of an offer on behalf of Costa Rica or the other Latin American countries to bring about a settlement of the Goa issue. The question of making use of such an offer does not, therefore, arise.
