Central Health Service

Will the Minister of Health be pleased to state the number of posts allotted to each Ministry under the Central Health Service and the designation of each such post ?

The Minister of Health (Rajkumari Amrit Kaur) : The Central Health Service will consist of all Class I and Class II posts under the various Ministries, except the Ministries of Railways and Defence. As all the existing and future posts of the above categories will form part of the service, the question of allotting any specified number of posts to a particular Ministry does not arise.

Railway Fares

Will the Minister of Railways be pleased to state :

(a) whether the Railway fare which is charged from a passenger in each class means only transit charges or includes amenities also; and

(b) if so, the proportion between the two?

The Parliamentary Secretary to the Minister of Railways and Transport (Shri Shah Nawaz Khan): (a) The Railway fare charged from a passenger in each class is meant to cover not only the transit charges but also the provision of such amenities as are usually provided for use without payment of any additional charges.

(b) It is not possible to work out the proportion between the two.

शाजापुर में डाक और तार घर

१४१६. श्री भ० न० मालवीय : क्या संचार मंत्री यह बताने की कृपा करेंगे कि :

(क) मध्य भारत के शाजापुर नगर में डाक तथा तार विभाग के लिये जो नई इमारत बनाने का विचार ३ साल पहले था उसका निर्माण-कार्य शुरू न करने के क्या कारण हैं;

(ख) इस इमारत के निर्माण का कार्य कब से शुरू होगा; और

(ग) क्या ऐसे विकास-कार्य पूरी तरह से विभागीय कर्मचारियों की सँपे जाते हैं ?

संचार मंत्रालय में मंत्री (श्री राज बहादुर) : (क) लगभग १½ साल हुआ इस डाक-घर के लिए जमीन मिल गयी थी, परन्तु केन्द्रीय सरकारी निर्माण विभाग (C.P.W.D.) द्वारा नक्शों की तैयारी, उनकी छान-बीन तथा उनको अन्तिम रूप देने में और फिर उसके बाद उक्त विभाग द्वारा प्राक्कलन (Estimates) की तैयारी में अब तक समय लग गया है ।

(ख) इस योजना की मंजूरी के बारे में कारवाई की जा रही है । और फिर कोशिश की जायगी कि जितनी जल्दी हो सके काम प्रारम्भ कर दिया जाय ।

(ग) ऐसे काम केन्द्रीय सरकारी निम्न विभाग द्वारा किये जाते हैं ।
