Repeal of Laws regarding restrictions on Propagation of Religion by States

2557. SHRI G. M. BANATWALLA: Will the Minister of LAW, JUSTICE AND COMPANY AFFAIRS be pleased to state:

(a) whether Government are aware of acute restlessness among minorities, especially Christians and Muslims, consequent upon undue restrictions placed upon the fundamental right to propagate one's religion by some States like Orissa, Madhya Pradesh and Arunachal Pradesh;

(b) whether Government propose to consider to nullify such undue restrictions through an amendment of the Constitution or appropriate legislation pursuant to residuary powers under Union List to repeal such laws; and

(c) if so, when such legislation is likely to be introduced?

THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI P. SHIV SHANKER): (a) There were some apprehensions in the minds of the concerned minorities on this issue. The validity of the Orissa Freedom of Religion Act, 1967 and the Madhya Pradesh Dharma Swatantra Adhinyam 1968 was challenged in the concerned High Courts and on appeal the Supreme Court upheld the constitutional validity of the impugned legislations

(Rev. Stainislaus V. State of M.P.—AIR 1977 SC 908). The Arunachal Pradesh Freedom of Religion Act, 1978 is simialr to the legislations upheld by the Supreme Court.
