expressed their difficulties in regard to procurement of essential supplies. Government have taken all possible measures to meet the shortages in the region.

## Withdrawal of Cases pending in Court by C.B.I.

361. SHRI NARAYAN CHOUBEY: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that CBI has withdrawn various cases, pending in courts, which were filed as a result of Shah Commission of Enquiry;
  - (b) if so, the details thereof; and
- (c) whether the Ministry had given permission to withdraw these cases?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHKI P. VENKATASUBBAIAH): (a) to (c) So far as cases pending in the Courts, which were filed as a result of the Shah Commission of Enquiry are concerned, in the following two cases, the appropriate courts have discharged the persons against whom charge-sheets had been filed:

- (1) RC 1/78-SIU(SIB I) relating to institution of criminal proceedings against certain officers and subjecting them to humiliation without justification, and
- (2) RC 2/78-SIU(SIB II) relating t<sub>0</sub> demolitions in Village Kapashera.

Another case RC 2/78-SIU(SIB.I) relating to the detention of Shri Bhim Sen Sachar and others was dropped by the Special Court and after further examination of the case. a closure Report was filed by the CBI which was accepted by the Court.

In another case, (RC 1/78-SIU(SIB. II) relating to alleged preparation of designs for Congress Party Posters by D.A.V.P., Government have recently come to the conclusion, after further examination of the case and with appropriate legal advice that action be taken as per law for withdrawal of the case.

## Agitation in Eastern Region

- 362. SHRI HARINATH MISRA: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) the magnitude of discontent and agitation in the Eastern Region of the country;
- (b) the various forces working openly or invisibly behind this agitation; and
- (c) the remedial measures that have been taken or are proposed to be taken to meet the situation?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOGENDRA MAKWANA): (a) to (c) Certain areas in the North Eastern Region have remeined disturbed due to secessionist activities of some insurgents groups. Recently, there has been wide-spread agitation over the issue 'foreigners' in Assam and to some extent, in Manipur and Meghalaya. There have also been clashes between tribals and non-tribals in Tripura.

Government are aware that certain foreign elements have been encouraging and giving assistance to insurgents and secessionist elements in the NE Region. Government are also aware that some communal organisations are instigating agitation not only in the NE Region, but also elsewhere. Government are keeping a close watch over the situation and have taken appropriate measures to deal with it.

# Supply of Coal to Thermal Power Stations

(SHRI CHARANJIT CHANANA): (a) Yes, Sir.

#### Reservation of Items for Small Scale Industries

365. SHRI AHMED M. PATEL: Will the Minister of INDUSTRY be pleased to state:

(a) the details of items meant for small scale industries;

- (b) whether Government are considering to review its policy with regard to small scale industries; and
  - (c) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI CHAPRANJIT CHANANA): (a) to (c) 834 items have been reserved for production in the small scale sector. These items are constantly reviewed by a Standing Committee set up for the purpose. This Committee also recommends ' reservation of additional items as well as de-reservation of items, if found necessary. Recently, the list of items reserved for the small scale sector was expanded from 807 to 834 items. The nomenclature of certain items already reserved has also been changed with a view to making the items more specific.
