Survey of Command Area Development

7774. SHRI RAJAGOPAL NAIDU: Will the Minister of IRRIGATION be pleased to state:

- (a) whether Command area development survey is to be taken up this year; and
 - (b) if so, the areas to be taken up?

THE MINISTER OF IRRIGATION (SHR KEDAR PANDAY): (a) Yes Sir.

(b) Two types of surveys, namely: Soil survey and topographical survey, are undertaken in the command area development projects. Upto March, 1980 soil and topographical surveys had been carried out in an area of about 6 million Ha. and 2.1 million Ha. respectively. Programme for the year 1980-81 is aimed at carrying out soil survey in an area of 0.9 million Ha. and topographical survey in an area of about 1.0 million Ha.

Issue of Licences for Coal Depois in Delhi

7775 SHRI BHEEKHABHAI: SHRI TARIQ ANWAR:

Will the Minister of ENERGY AND COAL be pleased to state:

- (a) whether it has been the practice to issue licences by Delhi Administration for coal depots in Delhi during the last three years on the recommendations of the Metropolitan Councillor of the area; and
- (b) if so, the number of licences for coal depots issued to the dependents and relations of the Metropolitan Councillers during the last three years; area-wise and full details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI VIKRAM MAHAJAN): (a) The coal depot licences are not sanctioned only on the recommendations of Metropoli-

- tan Councillors though their views are given due consideration.
- (b) Delhi Administration does not have any knowledge whether any of the person to whom coal depot licence has been given is related to the Metropolitan Councillors or not;

Magic Gas to replace Petroleum

7777. SHRI MADHAVRAO SCIN-DIA: Will the Minister of ENERGY AND COAL be pleased to state:

(a) whether Government's attention has been drawn to a report in the Tribune dated July 13, 1980 to the effect that a Surgeon-specialist

in Kidney transplant at PGI Chandigarh has in the course of his research for finding a gas capable of preserving the kidney to be transplanted alive for more than the usual period of about 15 minutes before actual Transplantation discovered a magic gas capable of replacing petroleum and running a scooter at a cost of only Rs. 1.25 for 600 kilometres as against the petroleum cost of about Rs. 100/- for an equal distance;

- (b) if so, what steps Government have taken to confirm the claim of the Surgeon of the PGI Chandigarh; and
- (c) the details of the process of production of the gas and its efficiency or use as the petroleum substitute?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI VIKRAM MAHAJAN): (a) to (c). The Government have no knowledge about the discovery of the magic gas capable of replacing petroleum by a Surgeon, of the Post Graduate Institute, Chandigarh. However, the information would be collected and laid on the Table of the House.

Report of Expert Committee in respect of Rationalisation of Production of Drug Formulations

Money spent by Large Industrial Houses for sending their Executives Abroad

- (a) whether he is aware that some of the large industrial houses are spending some lakes of public money on sending their executives to Harvard and other foreign Universities for studies:
- (b) whether these so-called studycum-pleasure trips at the cost of the share-holders are subjected to any check or scrutiny at any stage before finalisation of their enrolment; if so, what and if not, the reasons therefor;
- (c) whether any effort is being made to check whether such studies are available or can be made available in India and huge spending of money on payment of fees to the foreign universities and Institutes and other expenditure can be avoided and shareholders' money safeguarded; if not, the reasons therefor: and
- (d) whether Government propose considering controlling such wasteful spending by these Houses in the name of foreign training at huge expense; and if not, the reasons therefor?

THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI P. SHIV SHANKER): (a) Under the provisions of the Companies Act, 1956, Companies are not required to disclose in their annual accounts information in regard to the expenditure incurred on sending their executives to foreign Universities for studies.

(b) to (d). The Ministry of Finance has laid down guidelines in regard to courses of training for which foreign exchange may be released, e.g. for management courses to be attended by people with good academic record and holding a senior managerial post in a reputed concern.
