Average cost of Power Generation in each State

7787. SHRI MADHAVRAO SCIN-DIA: Will the Minister of ENERGY AND COAL be pleased to state:

- (b) whether the proportion of the hydro-electric installed capacity in the entire power generation set-up has dwindled during the past 15 years since 1965-66, if so, to what extent and how it has affected the average power generation and overall power supply position; and
- (c) what steps are contemplated under 6th Five Year Plan to increasingly divert to hydro-electric power generation and the targets fixed in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI VIKRAM MAHAJAN): (a) The overall cost of generation depends on the ratio of hydel and thermal power in the system and also the capital cost of individual hydro projects. How-
