(b) to (d). After nationalisation many of the small taken-over mines were re-grouped based on geographieconomic and administrative convenience. Some of the units were closed mainly due to inadequate reserves, seasonal nature the mines, poor quality of coal, inthe mines, poor quality of coal, ininfra-structure like roads Railway transport facilities, etc.

Geological Survey of India and Mineral Exploration Corporation have taken up detailed drilling and exploration of Hurra basin in Rajmahal coalfield. Government have already sanctioned a major opencast project at Rajmahal for a production of 5 million tonnes per annum at an investment of Rs. 87.43 crores which will create additional employment potential. More projects will sanctioned be as and when additional mineable coal reserves are proved by drilling and exploration.
