shore facilities there. A sum of Rs. 11.07 lakhs has been sanctioned for the construction of a fishing harbour at Namkhana.

Five Fish Farmers' Development Agencies covering five districts have been sanctioned for West Bengal. The World Bank assisted Inland Fisheries Project would cover 11 districts of West Bengal (including the five FFDA districts). The Central Government will provide Rs. 2.91 crores for the project and the Agricultural Refinance Development Corporation Rs. 5.59 crores.

Functioning of Mandsaur Telephone Exchange (MF)

4051. SHRI B. R. NAHATA: Will the Minister of COMMUNICATIONS he pleased to state:

- (a) whether the Mandsaur Exchange in Madhya Pradesh is not functioning we'll and the equipment of the Exchange goes out of order most of the time;

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KARTIK ORAON): (a) and (b). The Mandsaur exchange is functioning satisfactorily. However, there were a few cable break downs in June, 1980 resulting in increased complaints.

(c) The cable faults have since been rectified.

Admission in 11th Class to Students passing Prathama Examination

(b) The Prathama Examination of the Hindi Sahitya Samelan Prayag has been recognised as equivalent to Matriculation standard in Hindi alone and not the full Secondary (Matriculation) examination conducted by the Central Board of Secondary Education which includes study of two languages, mathematics science, social sciences, socially useful productive work, physical and health education.
