Reservation of Posts for SC & ST in the Ministry

- LAKSHMAN MAL SHRI 4131. LICK: Will the Minister of EDUCA-TION be pleased to state:
- (a) the number of posts reserved for the Scheduled Castes/Scheduled Tribes in his Ministry which remained vacant on the 1st June, 1980; and
- (b) the reasons for not filling up of these posts and when these posts are likely to be filled up?

THE MINISTER OF **EDUCATION** & HEALTH AND SOCIAL WEL-FARE (SHRI B. SHANKARANAND): (a) and (b). The posts in the Ministry of Education & Culture fall in the under-mentioned two categories:-

- (i) Posts in respect of which recruitment is made through the Department of Personnel and Administrative Reforms:
- (ii) Posts in respect of which recruitment is made by the Ministry.

In so far as (i) above is concerned, these normally cover the posts to be filled by officers from I.A.S. and other Central services including C.S.S. etc. The number of vacancies in these posts/grades is intimated to the Department of Personnel and Administrative Reforms from time to time. That department keeps in view the reservation orders at the time of actual recruitment.

As regards category (ii) above, 12 posts reserved for Scheduled Castes and 5 posts reserved for Scheduled Tribes were lying vacant on 1st June, 1980.

Requisitions have been sent to the selecting agencies, viz., U.P.S.C. Selection Commission, etc., for filling these vacancies.

Fishing Harbour at Gopalpur, Orissa

THE MINISTER OF AGRICULTURE RURAL RECONSTRUCTION AND (SHR_I BIRENDRA SINGH RAO): (a) Yes, Sir. A proposal was received from the State Government in July, 1979 for development of a commercialcum-fishing harbour at Gopalpur. The proposal was referred to Pre-Investment Survey of Fishing Harbours Project for technical clearance. Their comments have been forwarded to State Government for modifying the proposal. It is awaited.
