## Investment of Multinational Corporations in India

4214. SHRI BRAJAMOHAN MOHANTY: Will the Minister of LAW, JUSTICE AND COMPANY AFFAIRS be pleased to state;

- (a) names of multinational corporations operating through their subsidiaries in India and total investment in India on 31-3-1980; and
- (b) what steps Government have taken to curb their activities in the country?

THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI P. SHIV SHANKER): (a) The latest information available in this regard is as of 31-3-1979. On that date there were 125 subsidiaries of miltinational corporations operating in India, with a total paid up capital of Rs. 360.05 crores. The investment held by the foreign (holding) companies in the total paid-up capital was Rs. 215.96 crores. The details of the names of

the foreign companies and the amount of paid-up capital held by them in their Indian subsidiaries are published in the factsheets on Indian subsidiaries of foreign companies as on 31-3-1979. Copies of these factsheets are availaable in Parliament Library for reference.

(b) The activities of Indian subsidiaries of multinational corporations are controlled and regulated under the provisions of the Companies Act, MRTP Act Industries (Development & Regulation) Act, Foreign Exchange Regulation Λct and Capital Issues Control Act, as may, be relevant.
