(b) if not, the stations at which they are not being marketed;

- (c) the number of companies manufacturing these stoves; and
- (d) is there any request from any LPG distributors association to manufacture/or sell Nutan stoves; and if so, the action taken thereon?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI VEERENDRA PATIL): (a) No. Sir.

- (b) Due to limited availability, these stoves are marketed in whole of Delhi, Assam, Arunachal Pradesh, Chandigarh, Haryana, Manipur, Meghalaya, Mizoram, Nagaland, Tripura and parts of Himachal Pradesh, Jammu and Kashmir, Rajasthan, Uttar Pradesh and West Bengal only.
- (c) Presently only two companies are manufacturing these stoves. In order to maximise production to meet the demand in the country, National Small Industries Corporation (NSIC), New Delhi, is setting up a number of units in different locations of the country for production of stoves in the small scale sector as per the Government policy.
- (d) Indian Oil Corporation (IOC) is not aware of any such request but the LPG distributors are, however, authorised to sell Nutan stoves in approved markets.

Ceiling on the Sale of LPG Refilis

4281. SHRI V. N. GADGIL: Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

- (a) whether there is any ceiling on the sale of LPG Refills by the LPG distributors and if so, the limit fixed for different cities and towns and the basis on which the same is fixed;
- (b) number of distributors who have reached the ceiling limit and when the others are going to be brought to the ceiling level; and

(c) whether there is any representation about the revision of ceiling: limit from the LPG distributors Federation and if so, the action taken one the same?

THE MINISTER OF PETROLEUM, FERTILIZERS: CHEMICALS AND (SHRI VEERENDRA PATIL): different: Taking into account the working conditions and the cost of areas, the operations in different ceiling as to the maximum number of refills of cylinders that a distributor would be allowed to handle per month has been fixed as given below:

- (b) The number of LPG distributors/sub-distributors who have reached the above ceiling limit is reported to be 120. It would be possible to released additional new connections to the remaining distributors so as to bring them up to the ceiling level only after product availability position improves.
- (c) Yes, Sir. It is under consideration.

Rationalisation of Areas of LPG Distributors

4282. SHRI V. N. GADGIL: WITH the Minister of PETROLEUM AND CHEMICALS be pleased to state:

(a) whether there is any move by Government to rationalise the areas of

ALPG distributors for an economical and efficient distribution system;

- (b) is there any representation to the Oil companies by the LPG distributors in this respect;
- (c) if so, the steps taken by the Oil companies; and
- (d) whether the IOC has allowed any distributor to operate in undefined areas to enroll customers in unrelated areas far from their show rooms?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI VEERENDRA PATIL): (a). Rationalisation of areas of LPG distributors is a continuous process. Based on appointment of new distritors, adjustment of areas is undertaken, if considered necessary, so as to ensure economic and efficient functioning of the distributorships.

- (b) and (c). Representations are received and duly considered by oil companies for taking remedial action.
- (d) Areas of operation of LPG distributors is defined in their appointment letted. However, in exceptional cases due to lack of potential in their original marketing areas, their area of operation is extended.

(SHRI VEERENDRA PATIL): (a) Names of the particular agencies/co-operative societies who were allotted cooking gas agencies in U.P. and Bihar during the last three years are under:-

- 2. RDSO Consumers Co-operative Societies Limited.

Bihar: None.

- (b) According to the policy then in force, 25 per cent of all the agencies were reserved for persons belonging to SC/ST and 2 per cent for physically handicapped. The remaining 73 per cent of the agencies were being awarded on commercial considerapreference being given tions. genuine and efficient Consumers Cooperative Societies, Agro-Industries Corporation etc. All appointments are made after inviting applications by issuing advertisements in newspapers in circulation in the area concerned and selection of candidates has to be made by a duly constituted Selection Committee set up for the purpose by respective oil companies. However, Government undertakings may be awarded agencies without advertisement procedure, if such agencies are run departmentally by them.
- (c) A large number of persons apply in respect of such agencies and complete records of such applications are not readily available. After selection of the agent is completed from among the applicants, the remaining applications are deemed rejected.
