offer them to consumers at cheap prices?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI VEERENDRA PATIL): (a) No such case has come to the notice of the Government.

(b) and (c). No, Sir. As per one of the conditions in most of the Industrial Licences granted to Foreign Companies, they are required to supply 50 per cent of the technical material produced by them to non-associated formulators. These latter are mostly Indian Companies.

Conservation of Monsoon Flood Waters for Irrigation purpose

- (a) whether it is a fact that Government have evolved schemes for conservation of monsoon flood waters now running waste into the sea for utilization in irrigation and power generation; and

THE MINISTER OF IRRIGATION (SHRI KEDAR PANDEY); (a) and (b) The Government have formulated a National Perspective for Water Resources Development which envisages creation of optimum storages on wherever various rivers, feasible. which will help in conservation of water now running waste into sea for utilisation in irrigation and po-The details of the wer generation. proposal are yet to be finalised in consultation with the States.

Central Assistance sought for new Power Projects at Power Ministers Conference

4319. SHRI MANPHOOL SINGH CHAUDHARY: SHRI P. M. SAYEED:

(a) whether it is a fact that during the State Power Ministers Conference

most of the States complained of paucity of funds and sought Central assistance for starting new power projects;

- (b) whether any assessment had been made about the financial assistance needed by the States, separately; if so, the details thereof; and
- (c) the reaction of Government thereto?

THE MINISTER OF STATE INTHE MINISTRY OF ENERGY (SHRI VIKRAM MAHAJAN): (a) to Some of the States like West Bengal, Uttar Pradesh, Himachal Pradesh made a reference to the need for Central assistance for some of their existing projects and for starting new projects. Under the present pattern, Central assistance to states is not given for any particular sector but is part of overall plan assistance.
