Functioning of H.M.T. at Bhavnagar

4426. SHRI RAMJIBHAI MAVANI: Will the Minister of INDUSTRY be pleased to state:

(a) whether the Government are aware that the Machine Tools Industry a public sector undertaking which is situated at Bhavnagar '(Gujarat State) is not working properly and not yeilding full production;

(b) if so, the reasons thereof;

(c) the steps taken for its full utilisation;

(d) what is the production since its inception;

(e) whether Government have appointed any Committee or propose to appoint such a Committee to go into the details of the same; and

(f) if so, the details thereof and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI CHARANJIT CHANANA): (a) The production performance of Gujarat State Machine Tools Corporation Limited at Bhavnagar is reported to be satisfactory.

(b) and (c). Does not arise.

(d) It has been reported that the Company commenced production in the middle of last year and produced 96 Centre Lathes during 1979-80. Actual production in the first quarter of 1980-81 has been 55 machines against the planned target of 50 machines. The company expects to achieve the targetted production of 300 machines set for the year 1980-81.

(e) No, Sir.

(f) Does not arise.

Setting up of Central Environmental Agency

4427. SHRI B. K. NAIR: Will the PRIME MINISTER be pleased to state: (a) whether Government propose to get up a Central Environmental Agency; and

(b) if so, details covering its scope, a functions, powers and constitution?

THE MINISTER OF STATE IN OF MINISTRY DEFENCE THE SINGH): (SHRI C. P. N. (a) In 1972 the Government of India constituted the National Committee on Environmental Planning and Coordination (NCEPC) to advise the Government in all matters relating to the environment. The Committee consists of leading ecologists, naturalists and environmental specialists as well as heads of concerned administrative departments of the Government. The Department of Science and Technology has been entrusted with the responsibility of dealing with environmental matters and provides Secretariat support for NCEPC. More recently, in February 1980, Government has constituted a Committee under the chairmanship of the Deputy Chairman, Planning Commission, to review the existing legislation and administrative arrangements at the Central and State levels for environmental conservation and protection, and to recommend suitable measures to ensure environmental quality. The Committee is expected to submit its report by July 31, 1980. The recommendations of the Committee are to be considered by the Government in making decisions regarding immediate and long term measures for environmental protection and conservation.

Allocation of Cement to West Bengal

4429. SHRI CHITTA MAHATA: Will the Minister of INDUSTRY be pleased to state:

(a) the total allocation of cement to the State of West Bengal during the last 5 months; and

(b) the reasons for short supply?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI CHARANJIT CHANANA): (a) and (b). The ellocation of Cement to the States is made on a quarterly basis. The total allocation made to the State of West Bengal for the period January—June, 1980 was 5,84,000 tonnes. The supply was, however, less on account of the fact that the actual availability of cement was less than what was anticipated at the time when allocations were made.

Manufacture of Telecommunication Equipment under Private Sector

4431. SHRI P. M. SAYEED: Will the Minister of INDUSTRY be pleased to state whether Government are likely to amend the Industrial Policy resolution to enable private sector units to manufacture telecommunication equipments worth Rs. 200 crores currently being imported?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI CHARANJIT CHANANA): No, Sir.

Requirement of Raw Materials by Small Scale Units in Gujarat

4432. SHRI AMARSINH V. RATHAWA: Will the Minister of INDUSTRY be pleased to state what are the requirements of different raw materials needed by different small scale indutries in Gujarat and the actual allotments made to them by the Centre?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI CHARANJIT CHANANA): There is no formal distribution control on basic raw materials (except in case of EC grade aluminium) and therefore no precise estimate of all raw material requirements of the Small Scale Sector is made by Government. In the case of EC grade aluminium, the Aluminium Controller in the Ministry of Steel & Mines directly allocates the material to the Cable & Conductor manufacturing units on the
