Export of H.M.T. Watches

4462. SHRI N. DENNIS: Will the Minister of INDUSTRY be pleased to state:

- (a) whether H.M.T. watches are exported to other countries;
- (b) the details of the countries to which they are exported;
- (c) the quantity exported during the last five calendar years;
- (d) the amount for which exported for the same period; and
- (e) the types of watches exported to these countries?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI CHARANJIT CHANANA): (a) Yes, Sir. However, HMT's watch production is mainly to meet the domestic demand of watches and only a limited quantity has been exported mainly to middle east and neighbouring countries.

- (b) Watches have been exported to Bhutan, Dubai, Kuwait, Sri Lanka, Hong Kong, Malayasia. Australia, Canada, West Germany, Switzerland and USA;
- (c) and (d). The quantity and value of the watches exported during the last five years is as under:—

THE MINISTER OF STATE IM THE MINISTRY OF INDUSTRY (SHRI CHARANJIT CHANANA): (a) to (c). An Iranian delegation led by H.E. Mr. Reza Sadr (Minister of Commerce which visited India in June 1980 had discussions with the Minister of State for Industry on the possibilities of strengthening bilateral, economic and industrial cooperation between India and Iran. The Iranian side stated that they had a highly technical and sophisticated industrial base in Iran which needs revival. The Indian side offered to assist Iran in building up its industrial infrastructure and in the transfer of modern technology suited to Iran in the
