(d) Oil companies have planned to open five retail outlets in the State of J & K during the current year.

(e) Considering the demand, the number of outlets in J & K in relation to other States does not appear to be low.

(f) Does not arise in view of (e) above.

# Strengthening of Cuddapah A.I.R. Station

5098. SHRI P. RAJAGOPAL NAIDU: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) whether it is a fact that Cuddapah A.I.R. Station is very weak to cater to the seeds of Rayalaseema; and

(b) if so, whether Government are contemplating to strengthen the station?

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRIMATI RAM DULARI SINHA): (a) The 20 KW MW transmitter at Cuddapah does not cover the entire Rayalaseema area. The hilly terrain around Cuddapah is the chief reason for this inadequate coverage. (b) A proposal to upgrade the power of Cuddapah transmitter to 100 KW/ MW is being considered for inclusion in the 6th Plan (1980-85) proposals. Its implementation will, however depend upon the availability of resources and relative priorities.

#### Prices of Drugs

5099. SHRI B. R. NAHATA: Will the Minister of PETROLEUM AND CHE-MICALS be pleased to state how many times the prices of drugs have been increased during the last five years and to what extent?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZARS (SHRI VEERENDRA PATIL): There has been no general revision of the prices of either bulk drugs or formulations during the last five years. However, the prices of individual bulk drugs and formulations have during this period, undergone changes which include increases as well as decreases.

The enclosed statement indicates the price increases allowed for bulk drugs (which are price controlled under DPCO, 1979) during the period 1975-76 to 1978-79. [Placed in Library. See No. LT-1168/180]. After March, 1978 Government have not allowed any increases in the prices of bulk drugs except in the following cases:

As regards increases allowed in the prices of formulations during the period 1975-76 to 1977-78, since the number of formulations runs into thousands, the time and efforts involved in compiling details of such increases would not be commensurate with the results likely to be achieved. After, March, 1978, Government have not allowed any increases in the prices of price controlled formulations except on account of special duty of excise ut excise duty 5 per cent of the basic levied in the 1980-81 Budget proposal on all the patent and proprietary medicines.

### 5100. SHRI M. V. CHANDRASHE-KHARA MURTHY: SHRI B. V. DESAI:

Will the Minister of PETROLEUM AND CHEMICALS be pleased to state.

(a) whether it is a fact that many countries have now come forward to help and assist India in oil exploration;

(b) if so, which are the countries that have agreed to help;

(c) whether Canada is among them and has offered a loan to India for purchasing gas equipment etc.;

(d) if so, what are the other countries which have offered the loan; and

(e) to what extent this will help India in oil exploration?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI VEERENDRA PATIL: (a) to (e): Information is being collected and will be laid on the tabe of the Sabha.

पेट्रोलियम रसायन और उर्वरक मंत्री (औ वौरन्द्र पाटिल): (क) जौर (ख) गैस पर आधारित भावी उर्वरक संयंत्रों के लिये सम्मावित स्थानों की जांच के लिये गठित कार्य दल ने सरकार दवारा बताया है कि इनमें से एक संयंत्र मध्य प्रदेश में स्थापित किया जा सकता है। तथापि, एक उर्बरक संयंत्र की स्थापना के निर्णय इन्फ्रास्टक्चर की उपलब्धता कच्चे माल और तैयार उर्वरकों के परिवहन तकनीक तथा अन्य सम्बन्धित तकनीकी आर्थिक विचारों को ध्यान में रखते हुये किये जाती है। भविष्य में कार्यान्नित किये जाने वाले उर्नारक सयंत्रों फ्रेनिश्चित स्थान के बारे मे निर्णय लेना तभी सम्भव हो पायेगा जब विस्तृत तक-नीको आर्थिक अध्ययन पुरे हो जाये।

# Shortage of L. P. in towns of Bihar

5102. SHRIMATI KISHORI SINHA: Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

(a) whether it is a fact that there is acute shortage of L.P.G. for domestic use in Bihar towns;

(b) whether any plan is prepared for the supply of LPG to these areas; and

(c) if so, the details thereof?

THE MINISTER OF PETROLEUM. CHEMICALS AND FERTILIZERS (SHRI VEERENDRA PATIL): (a) Yes, Sir. There is a back-log in refill supplies by the Indian Oil Corporation in Bihar Town due to the closure of Barauni refinery.

(b) and (c). To the extent possible assistance is being rendered by moving the product from the Haldia refinery.

# Mixing of kerosene in Diesel

5103. SHRI G. NARSIMHA REDDY: Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

(a) is it a fact that earlier the prices of diesel and kerosene were kept at the same level to discourage mixing of kerosene in diesel;
